## Interpretation

1 In this regulation:

“**Act**” means the *Education, Health and Social Development Act*.

“**Agreement**” means the Local Education Agreement currently in force, as negotiated between Tsawwassen First Nation and the Delta School District

“**Manager**” means the Manager of Education and Skills Development of the Tsawwassen First Nation.

## Delegation of Chief Administrative Officer’s authority

2 The Manager of Education and Skills Development has the delegated authority by the Chief Administrative Officer, to provide instructional support services to Tsawwassen students, in accordance with the Act and these regulations.

## Provision of instructional support services

3 The following instructional support services are provided to Tsawwassen students through the Agreement:

- (a) Language and cultural education.
- (b) Transportation.
- (c) Guidance.
- (d) Other support and ancillary services, including an education and support worker.

## Provision of other instructional and extra-curricular support services for school age children

3.1 (1) The Executive Council may provide additional instructional support and extra-curricular support services to Tsawwassen students and to other Tsawwassen Members of school age who are ordinarily resident in Canada or the United States, including but not limited to

- (a) youth grants for accredited extra-curricular activities, and
- (b) funding to cover additional school fees.

(2) If the Executive Council provides services pursuant to subsection (1), they must establish the parameters for the service in policy, and if the supports include a financial grant, the dollar amount of the grant must be prescribed in this regulation or in the corresponding policy document.

**Rates**

- 4 Student allowances are provided to Tsawwassen students and Tsawwassen Members of school age who are ordinarily resident in Canada on the following basis:

8	\$25
9	\$25
10	\$25

**Deductions from allowances for unexcused absences**

- 5 The allowances provided for in Section 3 are based on full-time attendance at school. Allowances will be deducted at the rate of \$1 for every unexcused absence from class. Deductions will be based on the weekly attendance reports provided by schools to the Manager.
