EMPLOYMENT OPPORTUNITY Utility Systems Operator– Full Time

Tsawwassen First Nation (TFN) has invested more than \$100 million in new infrastructure, including a \$27-million wastewater treatment plant, essential for the development taking place on its Treaty Lands. The TFN Wastewater Treatment Plant is a state of the art EOCP level III facility commissioned in January of 2016. It was designed to treat up to 8,000 M3 per day. The final effluent is treated to re-use quality (purple pipe). The process utilizes Xylem's proprietary Intermittent Control Extended Aeration System with effluent filtration and UV disinfection.

This TFN facility and infrastructure is highly automated, with water and wastewater systems that will require ongoing maintenance and servicing. The **Utility Systems Operator** is EOCP certified with level 2 WD and will provide the ongoing maintenance of the water distribution and wastewater collection systems.

Specific Responsibilities

- Ensure timely monitoring and maintenance of the sewage collection and water distribution systems
- Participate in an "on call" system for after-hours and week-end system emergencies
- Collect water quality samples
- Respond to ratepayer complaints and queries
- Work as part of a cooperative team effort, to maintain and repair as required, the "underground" sewage collection, water distribution and stormwater drainage systems, including pump stations, hydrants, valves, meters and PRVs
- Maintain EOCP certification by completing required training and coursework
- Will be cross-trained to provide backup to the sewage treatment plant operators
Duties may be re-assigned as required

Requirements:

- Current Level 1 or 2 Environmental Operators Certification Program (EOCP) certification in water distribution and/or wastewater collection

Requirements cont'd:

- Experience working safely and effectively in the wastewater collection and storm water collection systems, including hands on experience of installation, maintenance and repair of sewer main, storm mains, lift stations, pumps, pressure reducing valves (PRVs), manholes, and other related collection system components
- Mechanical/Electrical educational Background
- Work experience in a water/sewer treatment plant environment highly desirable
- Experience in operation and maintenance of electrical and/or instrumentation systems
- Knowledge of preventive, predictive maintenance and condition monitoring techniques
- Excellent written and verbal communication. Able to communicate professionally with customers, engineers, owners and contractors
- Valid class 5 driver's license with drivers abstract
- Criminal background check required
- Preferred: Current Work Safe BC "OFA level 1" certification
- Preferred: Current confined space entry and rescue certification
